Rhetoric need not be truthful.


## What is anti-immigrant rhetoric?

Words and metaphors that demonize and stigmatize immigrants.

Words that portray immigrants as a threat and a burden.

This rhetoric relies on racism and xenophobia (fear of what is perceived as foreign or strange).


# To Be Clear: There Is Also Language that Evokes A Positive View of Immigrants and Immigration

- "We are a nation of immigrants."
- Ellis Island
- The Statue of Liberty
- The "DREAMers" (undocumented immigrants who came to the United States at age fifteen or younger)

## Anti-Immigrant Rhetoric Is Based on and Increases Xenophobia and Racism

#### This leads to:

- Discriminatory policies
- Increases in hate speech and attacks based on hate
- Undermines democracy



### What are Anti-Immigrant Policies?

Historically, there are many kinds of anti-immigration policies. Recently, they fall into six categories:

- preventing people from entering the country;
- denying legal status to those who apply for it;
- taking away legal status from those who had it;
- eliminating process protections in how people are treated by the immigration agencies;
- detaining, deporting and terrorizing immigrant communities;
- retaliating against anyone who speaks out against these policies.





## Anti-Immigrant Rhetoric and Policies Negatively Impact Immigrants' Physical and Mental Health



## Anti-Immigrant Rhetoric and Associated Policies are a Psychosocial Stressor



Psychosocial stressors can lead to adverse changes in health status and altered behavioral patterns that increase health risks.

## Four pathways through which state-level immigration policies may influence Latino health:

- Through stress related to structural racism;
- By affecting access to beneficial social institutions, particularly education;
- oBy affecting access to healthcare and related services; and
- Through constraining access to material conditions such as food, wages, working conditions, and housing




Fig. 3. Theorized pathways through which immigration-related policies and policies relevant to immigrants may influence Latino health.

## Numerous research studies arrive at similar conclusions:

"Escalating xenophobic political rhetoric, proliferating policies restricting migration, increased interior enforcement, and regulatory changes impeding resource access all contribute to a hostile environment for immigrants that is detrimental to adults and children....The chronic stress and deprivation that stem from these conditions produce toxic levels of stress that last a lifetime for children and adults alike." — (Danaher et al., 2022)

The effects are felt by documented as well as undocumented immigrants.

### What are the Mental Health Effects of Anti-Immigrant Rhetoric on Immigrants Themselves?

#### Examine Individual and Institutional Biases

- Self-reflection is necessary to understand biases and misconceptions toward immigrants, regardless of legal status.
- Institutional self-assessment is as important as individual self-assessment.
- ols the institution discriminating against immigrants? Are policies hostile toward immigrants?

## Listen Compassionately and Safely

The best strategy is to arm yourself and your patients with the knowledge to protect everyone's right to obtain healthcare.

## What Can Health Care Workers Do?

- Clinicians need to ensure that health care spaces signal that all people are welcome and that care is delivered to all regardless of citizenship status.
- o"No hate, no fear. Immigrants are welcome here." This can be followed by messaging on forms, such as "If you are experiencing fear or harm due to being an immigrant, please tell your provider."

#### What Can Health Care Workers Do?

- Learn the basics of immigration policy and stay informed of changes.
- Stay informed about the current policies at the state and local levels that may have an impact on your patient population.
- •Being informed about local goings-on like billboards, protests or community gatherings, or, more broadly, social media campaigns, is important. It may be useful to set aside time during staff or team meetings to share information about facts and rumors circulating in the community.
- Health care facilities may also want to create fliers that direct patients to local resources that assist immigrants, including community advocacy groups.


